Let us focus an the capital of pension funds The Special Purpose Vehicles created in terms of Regulation 29 of the Pension Funds Act 24 of 1956 allowed a small number of Government approved equity investment firms to manage 10% of all pension fund contributions of all Namibians that contribute to pension funds in unlisted asset classes. These unlisted asset classes are high risk vehicles that are increasingly being used to move money away from especially the middle class. that are able to contribute more to pension funds compared to lower end earners and/or the affluent.

Both the Office of the Prime Minister and the Ministry of Finance were involved in the recent increase to 10% allowed in terms of the Special Purpose Vehicles, Equity firms are laughing all the way to the bank. They are allowed to make investments in high risk start-ups with political connections without any consequences. Unlisted mandates are supposed to finance Greenfield startups (high

risk) for economic devel-

opment and job creation

but are doing low risk Brownfield investments instead?

How long will the foundation of the Harambee House hold before the structural cracks become so de-structural to the walls (the middle class metaphorically) that the roof collapse? The government is in-

creasingly setting investment priorities and rules for pension funds without proper checks and balances. This means government is becoming increasingly unaccountable.

Another example is the Estate Agents Act 112 of 1995, in which government is increasingly taking over the private sector's control over private assets. Discretionary powers of ministers have increased in terms of the Fisherles Act, Environmental Management Act, the Namibia Investment Bill and the New Economic Empowerment Equitable Framework.

INCREASED AUTO-CRATIC POWER

The increasing autocratic power of ministers in terms of these Acts and policies are illustrations of increasing patterns of socialism that have similarities with Zimbabwe and Venezuela. The political, economic and regulatory power are increasingly being fused by elites that is becoming more uncountable to those that stay in the Namibian House. The power of Big Brother is seemingly unlimited. Or is it?

In building the One

House of Reconciliation, some people seem to be more equal than others, as Joseph Diescho once said. Structural cracks in the foundation of our Namibian House are obscured from the men in the street that passes our house every day. When will the tipping point be reached? As Du Pisani said: "When is passive resignation going to give way to indignation and anger?" Will we be ableto hear and see when the roof collapse? Based on history, the tipping point of a dysfunctional state into complete chaos has never been common knowledge. What is your accountability to prevent such as collapse? Or are you still unaware about the cracks in our foundation?
